To launch the Competitive Entrance Examination into the First year undergraduate Programme (Bachelor of Engineering) of the Institute of Fisheries and Aquatic Sciences of the University of Douala at Yabassi and at the Higher Institute of Agriculture and Management (ISAGO) at Obala, a private Institute of Higher Education authorized to offer the same training within the framework of academic mentorship and fixing the number of places offered for the 2023/2024 academic year.

DECIDES:

Article 1: (1) For the 2023/2024 academic year, a competitive written exam is organized for the recruitment of one hundred and eighty (180) candidates in the first year Common Core at the Institute of Fisheries and Aquatic Sciences (ISH) from the University of Douala in Yabassi and the Higher Institute of Agriculture and Management of Obala (ISAGO), Private Institute of Higher Education under the academic mentorship of the University of Douala and under the technical supervision of the ISH. The training takes place full-time (daytime classes) and the distribution of places is as follows:

ISH – Yabassi	ISAGO – Obala
100	80

Of the hundred (100) places at the ISH, twenty (20) are reserved for civil servant candidates and ten (10) for foreigners. The examination centres are: DOUALA, DSCHANG, NGAOUNDERE, OBALA, YABASSI, and YAOUNDE.

(2) An applicant must choose to compete only for admission into only one of these Institutions.

Article 2: The competitive entrance examination is open to candidates of both sexes,

- Holders of the baccalaureate series C, D, F6, F7, F8, I; BT Agriculture or equivalent;
- Holders of the GCE-AL in Biology, Chemistry and Physics or Mathematics;
- Holders of the GCE-AL in Biology and Chemistry provided that the subjects were taken during the same session and that the GCE Ordinary Level included subjects like Physics or Mathematics;
- Holders of any other diploma accepted by the Minister of Higher Education as equivalent.

<u>Article 3:</u> Application files include the following documents:

- a) For candidates resident in Cameroun regularly registered in schools and civil servants
 - a duly stamped hand-written application to the Director of the Institute;
 - an application form to be filed online at the registration platform address: www.concours2023.ish.cm;
 - certified true photocopy of the birth certificate less than three (3) months old;
 - certified true photocopy of the required diploma;
 - five (5) passport size photographs (4×4) with candidates names written behind;

- a medical certificate delivered by a State medical doctor, testifying that the candidate is physically fit for university studies;
- transcripts of *Probatoire* or GCE/OL;
- transcripts of Baccalauréat or GCE/AL;
- An authorization for studies from MINFOPRA or from your Service Head for Civil Servants
- a receipt of payment of the sum of 20,000 CFA francs representing the registration fees;
- Two A4 size self-addressed envelopes bearing a 1,500 CFA F postal stamp (For the physical file).

b) For foreign candidates

Apart from the documents required in (a), they can be exceptionally admitted after a study of their files.

Article 4: The examination consists of a file study and written tests.

The study of the academic file (coefficient 1) is established according to the results of the Probatoire or the GCE "O" Level and the results of the baccalaureate or the GCE "A" Level. The following tests will be written:

- -a Biology test; except for holders of Bac F6, F7, F8 and BT Agricole, option (Animal production, Processing and Plant production) who will have a specialty test; lasting two hours (coefficient 2);
- -a Physics-Chemistry test, duration two hours (coefficient 1);
- -a Mathematics test lasting two hours (coefficient 1).

The exam syllabus is that of the Baccalaureate C, D, F6, F7, F8 and I, or equivalent, of the GCE "A" Level in the subjects: Biology, Chemistry, Physics, Mathematics and Computer Science, or BT. Agriculture, option: Animal Production, Processing, Plant Production.

Article 5: The registration fees for the entrance examination is the sum of 20,000 CFA francs payable to UBA to account n°10033 05214 140160 00004-94 of the Institute of Fisheries and Aquatic Sciences against a receipt to be attached to the application file. This non-refundable payment must imperatively be made in the name of the candidate and is intended to cover the expenses incurred by the organization of the competitive entrance examination.

Article 6: Candidates for the entrance examination to the first year at ISH must be at most twenty-eight (28) years old on January 1st of the year of the examination for regular candidates from schools or universities and forty-five (45) years at most for civil servant

candidates. For ISAGO, there is not age limitation.

<u>Article 7</u>: Registration for the competition is done online on the website of the Institute of Fisheries Sciences at the address: www.concours2023.ish.cm. All the required and certified documents must first be scanned and uploaded to the online registration platform. Then, the complete physical files must reach the following departments no later than **September 11**, **2023**:

- Rectorate of the University of Douala (Mail Service);
- ISH Liaison Office, located in the former deanship of the FGI (Douala);
- ISAGO Education Office in Obala
- Institute of Fisheries and Aquatic Sciences of the University of Douala in Yabassi (Education Service); or send to infos.ish@univ-douala.com or contact@ish.cm.
- Faculty of Agronomy and Agricultural Sciences (FASA) of the University of Dschang (Mail Department);
- School of Sciences and Veterinary Medicine (ESMV) of the University of Ngaoundéré;
- CRESA Forêt-Bois, Yaoundé (Secretariat of the Coordinator).

Only candidates with complete application files will be authorized to sit for the examination. They will then have to bring **their national identity card** which will be required.

Article 8: The competition will take place on September 12, 2023 at 8 a.m. sharp in the following centers: Douala (University of Douala), Dschang (Faculty of Agronomy and Agricultural Sciences), Ngaoundéré (School of Sciences and Veterinary Medicine), Obala (Higher Institute of Agriculture and Management of Obala), Yabassi (Institute of Fisheries and Aquatic Sciences), and Yaoundé (CRESA Forêt-Bois).

Article 9: The Rector of the University of Douala, the Director of University Accreditations and Quality and the Director of the Institute of Fisheries and Aquatic Sciences are each responsible for the execution of this decree which will be registered and published wherever
